PAID-UP OIL & GAS LEASE

This Lease made this 4th day of December 2010, by and between: Ira O. Lepley and Katherine L. Lepley (H&W), of 12756 Warwick Rd. Marshalville, OH 44645, hereinafter collectively called "Lessor," and TRI-STAR ENERGY HOLDINGS, INC., a Pennsylvania Corporation with mailing address of 107 East Lloyd Street, P.O. Box 330, Ebensburg, PA 15931, hereinafter called "Lessee."

WITNESSETH, that for and in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and of the mutual covenants and agreements hereinafter set forth, the Lessor and Lessee agree as follows:

LEASING CLAUSE. Lessor hereby leases exclusively to Lessee all the oil and gas (including, but not limited to coal seam gas, coalbed methane gas, coalbed gas, methane gas, gob gas, occluded methane/natural gas and all associated natural gas and other hydrocarbons and non-hydrocarbons contained in, associated with, emitting from, or produced/originating within any formation, gob area, mined-out area, coal seam, and all communicating zones), and their liquid or gaseous constituents, whether hydrocarbon or non-hydrocarbon, underlying the land herein leased, together with such exclusive rights as may be necessary or convenient for Lessee, at its election, to explore for, develop, produce, measure, and market production from the Leasehold, and from adjoining lands, using methods and techniques which are not restricted to current technology, including the right to conduct geophysical and other exploratory tests; to drill, maintain, operate, cease to operate, plug, abandon, and remove wells; to use or install roads, electric power and telephone facilities, and to construct pipelines with appurtenant facilities, including data acquisition, compression and collection facilities for use in the production and transportation of products from the Leasehold or from neighboring lands across the Leasehold, to use oil, gas, and non-domestic water sources, free of cost, to store gas of any kind underground, regardless of the source thereof, including the injecting of gas therein and removing the same therefrom; to protect stored gas; to operate, maintain, repair, and remove material and equipment.

DESCRIPTION. The Leasehold is located in the Township of Washington, in the County of Belmont, in the State of Ohio,

including lands acquired from Wells, Jeffrey L., Kimberly S., Kellie D., by virtue of deed dated 4.8.2008, and recorded in Deed Book 9147, at Page 320, at the Recorder's office of Belmont County, Ohio, and described for the purposes of this agreement as containing a total of 109.63 Leasehold acres, whether actually more or less, and including contiguous lands owned by Lessor. This Lease also covers and includes, in addition to that above described, all land, if any, contiguous or adjacent to or adjoining the land above described and (a) owned or claimed by Lessor by limitation, prescription, possession, reversion or unrecorded instrument or (b) as to which Lessor has a preference right of acquisition. Lessor agrees to execute any supplemental instrument requested by Lessee for a more complete or accurate description of said land.

LEASE TERM. This Lease shall remain in force for a primary term of Five (5) years from 12:00 A.M. December 30, 2010 (effective date) to 11:59 P.M. December 29, 2015 (last day of primary term) and shall continue beyond the primary term as to the entirety of the Leasehold if any of the following is satisfied: (i) operations are conducted on the Leasehold or lands pooled/unitized therewith in search of oil, gas, or their constituents, or (ii) a well deemed by Lessee to be capable of production is located on the Leasehold or lands pooled/unitized therewith, or (iii) oil or gas, or their constituents, are produced from the Leasehold or lands pooled/unitized therewith, or (iv) if the Leasehold or lands pooled/unitized therewith is used for the underground storage of gas, or for the protection of stored gas, or (v) if prescribed payments are made, or (vi) if Lessee's operations are delayed, postponed or interrupted as a result of any coal, stone or other mining or mining related operation under any existing and effective lease, permit or authorization covering such operations on the leased premises or on other lands affecting the leased premises, such delay will automatically extend the primary or secondary term of this oil and gas lease without additional compensation or performance by Lessee for a period of time equal to any such delay, postponement or interruption.

If there is any dispute concerning the extension of this Lease beyond the primary term by reason of any of the alternative mechanisms specified herein, the payment to the Lessor of the prescribed payments provided below shall be conclusive evidence that

the Lease has been extended beyond the primary term.

EXTENSION OF PRIMARY TERM. Lessee has the option to extend the primary term of this Lease for one additional term of five (5) years from the expiration of the primary term of this Lease; said extension to be under the same terms and conditions as contained in this Lease. Lessee may exercise this option to extend this Lease if on or before the expiration date of the primary term of this Lease, Lessee pays or tenders to the Lessor or to the Lessor's credit an extension payment of two-thousand, five hundred dollars (\$2,500.00) per Leasehold acre. Exercise of this option is at Lessee's sole discretion and may be invoked by Lessee where no other alternative of the Lease Term clause extends this Lease beyond the primary term.

NO AUTOMATIC TERMINATION OR FORFEITURE.

(A) CONSTRUCTION OF LEASE: The language of this Lease (including, but not limited to, the Lease Term and Extension of Term clauses) shall never be read as language of special limitation. This Lease shall be construed against termination, forfeiture, cancellation or expiration and in favor of giving effect to the continuation of this Lease where the circumstances exist to maintain this Lease in effect under any of the alternative mechanisms set forth above. In connection therewith, (i) a well shall be deemed to be capable of production if it has the capacity to produce a profit over operating costs, without regard to any capital costs to drill or equip the well, or to deliver the oil or gas to market, and (ii) the Lessee shall be deemed to be conducting operations in search of oil or gas, or their constituents, if the Lessee is engaged in geophysical and other exploratory work including, but not limited to, activities to drill an initial well, to drill a new well, or to rework, stimulate, deepen, sidetrack, frac, plug back in the same or different formation or repair a well or equipment on the Leasehold or any lands pooled/unitized therewith (such activities shall include, but not be limited to, performing any preliminary or preparatory work necessary for drilling, conducting internal technical analysis to initiate and/or further develop a well, obtaining permits and approvals associated therewith and may include reasonable gaps in activities provided that there is a continuum of activities showing a good faith effort to develop a well or that the cessation or interruption of activities was beyond the control of Lessee, including interruptions caused by the acts of third parties over whom Lessee has no control or regulatory delays

associated with any approval process required for conducting such activities).

(B) LIMITATION OF PORFETTURE: This Lease shall never be subject to a civil action or proceeding to embace a claim of termination, cancellation, expiration or forfoines due to any action or inaction by the Leuser, including, but not limited to making any prescribed payments authorized under the terms of this Leuse, unless the Leuser has received written notice of Leuser's demand and thereafter fails or refuses to existly or provide justification responding to Leuser's demand within 60 days from the receipt of such notice. If Leuser timely responds to Leuser's demand, but in good faith disagrees with Leuser's position and sets forth the reasons therefore, such a response shall be deemed to satisfy this provision, this Lesse shall continue in full force and effect and no further damages (or other claims for relief) will accrue in Lessor's favor during the pendency of the dispute, other than claims for payments that may be due under the terms of this Lease.

PAYMENTS TO LESSOR, In addition to the bosses paid by Lessee for the execution hereof, Lessee covenants to pay Lessor, proportionate to Lessor's percentage of ownership, as follows:

(A) DELAY RENTAL: To pay Lessor as Delay Rental, after the first year, at the rate of five dollars (\$5.00) per net-acce per year payable in advance. The parties hereto agree that this is a Paid-Up Lease with no further Delay Rental and/or Belay in Marketing payments due to Leaser during the primary term hereof.

(B) ROYALTY: To pay Lessor as Royalty, less all taxes, assessments, and adjustments on production from the Leasehold, as

follows:

1. OIL: To deliver to the credit of Lessor, free of cost, a Royalty of the equal fifteen and one-half nercent

(15.59%) part of all oil and any constituents thereof produced and marketed from the Leasehold.

2. GAS: To puy Lessor an amount equal to fifteen and enochalf nervent (15.59%) of the revenue realized by Lessor for all gas and the constituents thereof produced and marketed from the Leasehold, less the cost to transport, treat and process the gas and any losses in volumes to point of measurement that determines the revenue realized by Lessee. Lease may withhold Royalty payment until such time as the total withhold exceeds fifty dollars (\$50.00).

(C) DELAY IN MARKETING: In the event that Lessee drills a well on the Lessehold or lands pooled/unitized therewith that is awaiting completion, or that Lessee deems to be capable of production, but does not market producible gas, oil, or their constituents therefrom, and there is no other basis for extending this Lesse, Lessee shall pay after the primary term and until such time as marketing is established (or Lessee surranders the Lessee) a Delay in Marketing payment equal in amount and frequency to the annual Delay Rental payment, and this Lesse shall remain in full force and effect to the same extent as payment of Royalty.

(D) SHUT-IN: In the event that production of oil, gas, or their constituents is interrupted and not marketed for a period of tracks.

twelve (12) months, and there is no producing well on the Lenschold or lands pooled/unitized therewith, Lennee shall thereafter, as Royalty for constructive production, pay a Shut-in Royalty equal in amount and frequency to the annual Delay Rental payment until such time as production is re-established (or lessee surrenders the Lesse) and this Lesse shall remain in full force and effect. During Shat-in, Lessee shall have the right to rework, stimulate, or deepen any well on the Lessehold or to drill a new well on the Lessehold in an effort to re-establish production, whether from an original producing formation or from a different formation. In the event that the production from the only producing well on the Leasehold is interrupted for a period of less than twelve (12) months, this Lease shall remain in full force and effect without payment of Royalty or Shat-in Royalty.

(E) DAMAGES: Lease will remove unnecessary equipment and materials and reclaim all disturbed lands at the completion of activities, and Leasee agrees to repair any damaged improvements to the land and pay for the loss of growing crops or marketable

(F) MANNER OF PAYMENT: Lessee shall make or tender all payments due hereunder by check, payable to Lessor, at Lessor's last known address, and Lessee may withhold any payment pending notification by Lessor of a change in address. Payment may be tendered by mail or any comparable mothod (e.g., Federal Express), and payment is deemed complete upon mailing or dispatch. Where the due date for any payment specified herein falls on a holiday, Saturday or Sunday, payment tendered (mailed or dispatched) on the next business day is timely.

(G) CHANGE IN LAND OWNERSHIP: Lessee shall not be bound by any change in the ownership of the Leasehold until furnished with such documentation as Lessee may reasonably require. Pending the receipt of documentation, Lessee may elect either to continue to make or withhold payments as if such a change had not occurred.

(H) TITLE: If Lessee receives evidence that Lesser does not have title to all or any part of the rights herein lessed, Lessee may immediately withhold payments that would be otherwise due and payable hereunder to Lessor until the adverse claim is fully

(I) LIENS: Lessee may at its option pay and discharge any past due taxes, mortgages, judgments, or other liens and excumbrances on or against any land or interest included in the Leasehold; and Leases shall be entitled to recover from the debtor, with legal interest and costs, by deduction from any fisture payments to Lessor or by any other lewful means. In the event the leased lands are encumbered by a prior mortgage, then, notwithstanding enything contained herein to the contrary, Lessee shall have the right to suspend the payment of any royalties due becomed, without liability for interest, until such time as Lessor obtains at its own expense a subordination of the mortgage in a form acceptable to Lessee.

(I) CHARACTERIZATION OF PAYMENTS: Payments act forth herein are covenants, not special limitations, regardless of the manner in which these payments may be invoked. Any failure on the part of the Lesses to timely or otherwise properly tender payment can never result in an automatic termination, expiration, cancellation, or forfishme of this Lesse. Lessor recognizes and payment can be a construct of and gas lease payments, in the form of restal, bosos and royalty, can vary depending on available factors and that this Lease is the product of good faith negotiations. Leaser hereby agrees that the payment terms, as set forth herein, and any bosos payments paid to Leaser constitute full consideration for the Leasehold. Leaser further agrees that such payment terms and bonus payments are final and that Lessor will not seek to assend or modify the lesse payments, or seek additional consideration based upon any differing terms which Lessee has or will negotiate with any other lessonful and gas owner.

(K) PAYMENT REDUCTIONS: If Lessor owns a losser interest in the oil or gas than the entire undivided fee simple estate,

then the restriks (except for Delay Restall payments as set forth above), royalties and shut-in royalties hereunder shall be paid to Louor only in the proportion which Lessor's interest bears to the whole and undivided fee.

<u>UNITIZATION AND POOLING.</u> Lessor grants Lessee the right to pool, unitize, or combine all or parts of the Leasehold with other lands, whether contiguous or not contiguous, leased or unleased, whether owned by Lessee or by others, at a time before or after drilling to create drilling or production units either by contract right or pursuant to governmental authorization. Prolling or unitizing in one or more instances shall not exhaust Leasee's pooling and unitizing rights hereunder, and Leasee is granted the right to change the size, shape, and conditions of operation or payment of any unit created. Leaser agrees to accept and receive out of the production or the revenue realized from the production of such unit, such proportional share of the Royalty from each unit well as the number of Lesschold acces included in the unit beaus to the total number of acres in the unit. Otherwise, as to any part of the unit, drilling, operations in preparation for drilling, production, or shut-in production from the unit, or payment of Royalty, Shut-in Royalty, Dolay in Marketing payment or Delay Rental attributable to any part of the unit (including non-Leasehold land) shall have the same effect upon the terms of this Lease as if a well were located on, or the subject activity attributable to, the Leasehold. In the event of conflict or inconsistency between the Lessehold acres ascribed to the Lesse, and the local property tex assessment calculation of the

lands covered by the Lesse, or the deeded acreage amount, Lessee may, at its option, rely on the latter as being determinative for the purposes of this paragraph.

FACILITIES. Lesses shall not drill a well on the Lessehold within 500 feet of any structure located on the Lessehold without Lessor's written consent. Lessor shall not exect any building or structure, or plant any trees within 200 feet of a well or within 25 feet of a pipeline without Lessor's written consent. Lessor shall not improve, modify, degrade, or restrict roads and facilities built by Lesses without Lesses's written consent.

CONVERSION TO STORAGE. Lease is hearby granted the right to convert the Leasehold or lands pooled/unitized therewish to gas storage. At the time of conversion, Lease shall pay Leason's proportionate part for the estimated recoverable gas remaining in any well drilled pursuant to this Lease using methods of calculating gas reserves as are generally accepted by the natural gas industry and, in the event that all wells on the Leasehold and/or lands pooled/unitized therewith have permanently ceased production, Lesser shall be paid a Conversion to Storage payment in an amount equal to Delay Rental for as long thereafter as the Leasehold or lands pooled/unitized therewith in/are used for gas storage or for protection of gas storage; such Conversion to Storage payment shall first become due upon the next ensuing Delay Rental anniversary date. The use of any part of the Lesschold or lands pooled or unitized therewith for the underground storage of gas, or for the protection of stored gas will extend this Lease beyond the primary term as to all rights granted by this Lease, including but not limited to production rights, regardless of whether the production

LEASE DEVELOPMENT. There is no implied covenant to drill, prevent drainage, farther develop or market production within the primary term or any extension of term of this Loase. There shall be no Leasehold forfeiture, termination, expiration or cancellation for failure to comply with said implied covenants. Provisions herein, including, but not limited to the prescribed payments, constitute full compensation for the privileges herein granted.

COVENANTS. This Lease and its expressed or implied covenants shall not be subject to termination, forfeiture of rights, or damages due to failure to comply with obligations if compliance is effectively prevented by federal, state, or local law, regulation, or

decree, or the acts of God and/or third parties over whom Lessee has no comtrol.

RIGHT OF FIRST REFUSAL. If at any time within the primary term of this Lease or any continuation or extension thereof, Lessor receives any bonn fide offer, acceptable to Lessor, to grant an additional lesse ("Top Lesse") covering all or part of the Leasehold, Leasec shall have the continuing option by meeting any such offer to acquire a Top Lease on equivalent terms and conditions. Any offer must be in writing and must set forth the proposed Lessee's name, bonus consideration and royalty consideration to be paid for such Top Lesse, and include a copy of the lease form to be utilized reflecting all pertinent and relovant terms and conditions of the Top Lesse. Lessee shall have fifteen (15) days after receipt from Lessor of a complete copy of any such offer to advise Lessor in writing of its election to enter into an oil and gas lease with Lessor on equivalent terms and conditions. If Lessee fails to notify Lessor within the aforesaid fifteen (15) day period of its election to meet any such bonn fishe offer, Lessor shall have the right to accept said offer. Any Top Lease granted by Lessor in violation of this provision shall be sull and void.

ARBITRATION. In the event of a disagreement between Lessor and Lessee concerning this Lesse or the associated Order of Payment, performance thereunder, or damages caused by Lessee's operations, the resolution of all such disputes shall be determined by arbitration in accordance with the rules of the American Arbitration Association. Arbitration shall be the exchange roundy and cover all disputes, including but not limited to, the formation, execution, validity and performance of the Lease and Order of Payment.

All fees and costs associated with the arbitration shall be borne equally by Lessor and Lessoe.

ENTIRE CONTRACT. The entire agreement between Lessor and Lessoe is embodied herein and in the associated Order of Payment (if any). No oral warranties, representations, or promises have been made or relied upon by either party as an inducement to or modification of this Lesse.

TITLE CURATIVE. Lessor agrees to execute affidavits, ratifications, amendments, permits and other instruments as may be

necessary to carry out the purpose of this lease.

SURRENDER. Lessee, at any time, and from time to time, may marrander and cancel this Lesse as to all or any part of the Lessehold by recording a Surrender of Lesse and therespon this Lesse, and the rights and obligations of the parties heremoter, shall exminate as to the part so surrendered; provided, however, that upon each surrender as to any part of the Lesschold, Lessee shall have reasonable and convenient easements for then existing wells, pipelines, pole lines, roadways and other facilities on the lands aurendered.

SUCCESSORS. All rights, daties, and limbilities herein benefit and bind Lessor and Lessor and their heirs, successors, and

Lessee shall not be liable in damages for breach of any express or implied covenants of this Lesse or failure to comply therewith, if compliance is prevented by, or failure is the result of any applicable laws, rules, regulations or rules or operation of force majoure.

SEVERABILITY. This Lesse is intended to comply with all applicable laws, rules, regulations, ordinances and governmental orders. If any provision of this Leure is held by a count of competent jurisdiction to be invalid, void, or unembreable, the remaining provisions shall survive and continue in full force and effect to the maximum extent allowed by law. If a court of competent jurisdiction holds any provision of this Lease invalid, void, or menforceable under applicable law, the court shall give the provision the greatest effect possible under the law and modify the provision so as to conform to applicable law if that can be done in a manner which does not frustrate the purpose of this Leane.

COUNTERPARTS. This Lease may be executed in one or more counterparts, each of which will be dressed to be an original copy of this Lease and all of which, when taken together, will be deemed to constitute one and the same agreement. EXHIBIT A

Attached to and made a part of that certain Oil and Gas Lease dated the 4th day of December, 2010, by and between Ira O. Lepley and Katherine L. Lepley (H&W), as Lessor(s), and TRI-STAR ENERGY HOLDINGS, INC., as Lessee ("Lease"), to wit:

In the event of a conflict between the terms of this Exhibit "A" and the terms of the printed form to which it is attached, the terms of this Exhibit "A" shall control.

Lessor hereby warrants that Lessor is not currently receiving any bonus, rental, production royalty as the result of any prior oil and gas lease covering any or all of the subject premises, and that there are no commercially producing wells currently existing on the subject premises, or upon other lands within the boundaries of a drilling or production unit utilizing all or a part of the subject premises.

PRODUCTION

Commencement of Operations

Commencement of operations shall be defined as Lessee having secured a drilling permit from the State and Further entering upon the herein described premises with equipment necessary to build any access road(s) for drilling of a well subsequently followed by a drilling rig for the spudding of the well to be drilled.

Shut-It

It is understood and agreed that this lease may not be maintained in force for an continuous period of time longer than thirty-six (36) consecutive months, or sixty (60) cumulative months after the expirations of the primary term hereof solely by the provision of the shut-in royalty clause. The shut-in status of any well shall persist only so long as it is necessary to correct, through the exercise of good faith and due diligence, the condition giving the rise to the shut-in of the well.

Limitation on Pooled Unit

If a well drilled is classified as a horizontal oil or gas well drilled to any geologic formation whether oil or gas, then the maximum size of the pooled production unit shall not exceed 640 contiguous acres, except said production unit may exceed 640 contiguous acres, but in no event larger than 1,280 contiguous acres, if the lateral extent of horizontal wellbores in said formation extend beyond the boundary of a 640 contiguous acre unit, and/or in the event that a reasonably prudent operator would expect that the entire acreage within such larger unit will be effectively and efficiently developed and drained from a central pad site location. The pooled production unit shall to the extent practicable be parallel and centered on the lateral wellbores to be drilled within the unit. Lessor and Lessee agree to abide by any State pooling or unitization orders.

Pugh Clause






